

## CERTIFICATION, RELEASE, AND WAIVER

### A. CERTIFICATION

In view of the Novel Coronavirus Acute Respiratory Disease (2019-nCoV ARD) outbreak, I hereby certify that:

1. I have not traveled to China, Macau, Hong Kong or other areas with confirmed cases of 2019-nCoV ARD for the immediately preceding / past 14 days nor have I travelled to other parts of the world with confirmed 2019-nCoV ARD cases and shown symptoms such as fever and/or cough.
2. I have not had close contact (within one meter) with a confirmed case of 2019-nCoV ARD for the immediately preceding / past 14 days.
3. For the immediately preceding / past 14 days, I have not:
  - a. Provided care for and/or handled specimens of confirmed 2019-nCoV ARD patient or persons under investigation for 2019-nCoV ARD infection
  - b. Stayed in the same close environment as confirmed 2019-nCoV ARD patient or persons under investigation for 2019-nCoV ARD infection
  - c. Travelled together with confirmed 2019-nCoV ARD patient or persons under investigation for 2019-nCoV ARD infection in any kind of conveyance
  - d. Lived in the same household as confirmed 2019-nCoV ARD patient or persons under investigation for 2019-nCoV ARD infection

### B. WAIVER, INDEMNITY & RELEASE OF LIABILITY

1. I am fully aware of and understand the events and circumstances surrounding 2019-nCoV ARD.
2. I assume all risks associated with running the TBR Dream Marathon 2020, including any and all risks arising from or associated with the 2019-nCoV ARD.
